## **Register of Interests**

- Action in response to any declared interests applies to any involvement with the work of the Town Deal Board and is to be recorded.

Please note that if a spouse or partner is referenced within the Register of Interest they do not need to be referred to by name.

## **NOTIFICATION OF CHANGE OF CIRCUMSTANCES**

Even if a meeting has not taken place a Member must, within 28 clear working days of becoming aware of any change to the interests specified below, provide written notification to the S151 Officer, of that change.

\*SPOUSE/PARTNER – In the notice below my spouse or partner means anyone who meets the definition in the Localism Act, i.e. my spouse or civil partner, or a person with whom I am living as a spouse or a person with whom I am living as if we are civil partners, and I am aware that that person has the interest having carried out a reasonable level of investigation.
