1. An Election is to be held for a Member of Parliament to serve the Chesterfield constituency.
2. Nomination papers can be obtained from the offices of the (Acting) Returning Officer, Town Hall, Rose Hill, Chesterfield, S40 1LP, during the times stated below.
3. Nominations papers must be delivered to the (Acting) Returning Officer at the Town Hall, Rose Hill, Chesterfield, S40 1LP, by appointment only, on any day after the date of this notice, on Monday to Friday 10.00am to 4.00pm (excluding bank holidays) **but no later than 4.00pm on Friday 7 June 2024**. Please contact 01246 936860 to make an appointment.
4. The £500 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as banker in the United Kingdom or by electronic funds.
5. If the election is contested the poll will take place on Thursday 4 July 2024.
6. Applications to register to vote must reach the Electoral Registration Officer at the Town Hall, Rose Hill, Chesterfield, S40 1LP by 12 midnight on Tuesday 18 June 2024. Applications can be made online at [Register to vote - GOV.UK \(www.gov.uk\)](https://www.gov.uk/register-to-vote).

New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the Electoral Registration Officer at the Town Hall, Rose Hill, Chesterfield, S40 1LP by 5.00pm on Wednesday 19 June 2024. Applications can be made online at [Apply for a postal vote - GOV.UK \(www.gov.uk\)](https://www.gov.uk/apply-for-a-postal-vote).

Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer at the Town Hall, Rose Hill, Chesterfield, S40 1LP by 5.00pm on Wednesday 26 June 2024.
